Message From the CEO



Dear Friends,

This past year has been filled with challenges and new opportunities. The human, economic, and social crisis created by COVID-19 has exponentially increased the toll a pre-existing behavioral health crisis had already been taking on our nation. More families than ever before are suffering the devastating effects of depression, anxiety and overdose. More families than ever before need our help. I am proud to report that

throughout the pandemic, all Maryville programs and services remained open to provide life-saving treatment for our clients. Our dedicated medical, nursing, clinical, administrative, and support staff transformed care delivery to operate safely and effectively during these most difficult times. The high economic cost of added staff, physical plant modifications, and service delivery enhancements necessary to protect clients and staff is a weight we bear to provide the high quality service upon which our name and trust is built.

During the year, we expanded our telehealth options for assessment and treatment of substance use and mental health disorders. We renovated our Williamstown inpatient campus residence for women to prepare for service expansion. We increased licensed beds at our Pemberton campus to double our capacity to serve men in our long-term residential program. We worked with government and non-profit agencies throughout the region to expand outreach to underserved communities. We built upon our existing Alumni and Certified Peer Recovery Specialist (CPRS) services to build long term recovery capital for our clients. And we partnered with a statewide educational consortium and area colleges and universities to offer licensure and certification programs for our staff.

These are no small accomplishments amidst the most devastating health crisis we have seen in our lifetimes. The credit belongs to our board and staff, for whom the mission of service has never wavered. Thank you for your continued support as we continue to restore health and hope for our communities.

New Programming

Maryville Receives \$1,000,000 SAMHSA Grant

The Substance Abuse and Mental Health Services Administration (SAMHSA) awarded Maryville a \$1,000,000 grant to launch two Certified Community Behavioral Health Clinics (CCBHCs). This four-year grant will allow Maryville to plan and begin implementation of the CCBHCs at our outpatient sites in Turnersville and Vineland. CCBHCs offer coordinated, comprehensive behavioral health care in a single location and consist of substance use and mental health assessment and treatment, physical screenings and monitoring, case management, crisis intervention,



peer support, vocational assistance, veteran-specific care, and family services. Services are offered for all ages and are available regardless of an individual's ability to pay. The initiative will serve at least 800 unique individuals over four years.

Maryville Begins Contingency Management Program for Stimulant Users

With funding from the New Jersey Division of Mental Health and Addiction Services (NJDMHAS), Maryville was able to begin a Contingency Management program at its Turnersville and Vineland outpatient treatment sites. Stimulant use disorders do not typically respond to Medication Assisted Treatment. Contingency Management, a different evidence-based approach, uses an incentive program whereby individuals addicted to stimulants can earn monetary and other rewards for remaining clean. This program combines group and individual therapy with incentives and wellness programming to increase and maintain motivation to move forward in recovery.

New Programming

Maryville Launches Co-occurring Gambling Treatment in Inpatient Programs



NJDMHAS awarded Maryville funding to begin co-occurring gambling services at its Williamstown and Pemberton inpatient treatment programs. Individuals experiencing co-occurring substance use and problem gambling disorders receive group and individual counseling geared toward their specific needs. Clients have access to a licensed therapist who is certified in gambling treatment, as well as a Certified Peer Recovery Specialist (CPRS) to provide recovery supports in conjunction with their treatment program.

Peer Recovery Support Services Expand

With funding from Camden County, Maryville was able to begin providing peer services in conjunction with sober living placements. A sober living home is a home shared by individuals beginning lives without drugs and alcohol and is typically used as a transition between inpatient treatment and independent living. It is intended to serve as a supportive environment during a challenging time.

Peer services include a Certified Peer Recovery Specialist that provides recovery supports for up to one year posttreatment. The peer assists in whatever areas the individual needs support. Peers may help with employment, coordinating medical or mental health care, emotional support, and more. This service helps the individual to transition to their new lives. so they can sustain their recovery long-term.

On April 1, 2022, Maryville held its 9th Annual Recovery for Life Gala where we honored Louis Cappelli, Jr., Commissioner Director, Camden County and Dominic Vesper, Jr., Deputy Administrator, Camden County. Both have been public servants for more than 30 years and co-chair the Camden County Addiction Awareness Task Force

(CCAATF), which has yielded numerous initiatives including drug awareness campaigns, innovative programs to connect people with treatment, and sober activities for those in recovery.



Raymond Massi served as guest speaker for the event, sharing his own story of recovery. Ray has been in recovery for 35 years and recently retired as Deputy Director of the Philadelphia-Camden High Intensity Drug Trafficking Program, where he spent six years overseeing 25 federal, state, and local drug

task forces in South Jersey, Eastern Pennsylvania, and Delaware. Prior to that, he spent 14 years as the Law Enforcement Coordinator for the U.S. Attorney's Office (Department of Justice) in the District of New Jersey, and 27 years with the Camden City Police Department.

Nearly 300 people gathered at Tavistock Country Club for the gala and raised nearly \$160,000 for Maryville programs and services, so that we can provide lifesaving treatment and supports to those with substance use and co-occurring mental health disorders.

This year's Race for Recovery 5K and Fun Walk was a great success. On September 18, 2021, a beautiful day at Cooper River Park, approximately 175 participants chose to run or walk to support the Peter P. Black IV Scholarship Fund at Maryville, which helps reduce the cost of treatment for those who can't afford it. The event raised over \$17,000 and included a DJ, shirt, awards, refreshments, kids' activities, and post-race yoga.
